Breaking The Chains



The Nikita Koloff Story

I've traveled all over the world as a top athlete in professional wrestling. As far as "bad guys" go, I was one of the "baddest". The story was that I was a superior athlete who came off the boat, literally, from the Soviet Union to the United States to show Americans what a "real" athlete looked like. My professional wrestling character was a Russian guy who spoke not a word of English. That was the perception of who I was supposed to be. It worked. It is still one of the most talked about events in wrestling history.



The reality was that I was just a guy from the projects of Minneapolis, Minnesota who grew up on welfare. I lived the part of a Russian 24 hours a day, 7 days a week. For the first 13 months of my career, I never spoke a word of English in public or to anyone, except my Uncle Ivan Koloff. After this time, I only spoke in broken English.

The character that I “played” was a heartless, cold, and evil person, a man of no compassion for anyone whatsoever. This was an easy character for me to portray, as it wasn’t that far from the real me. (I would later become a “good guy” and a fan favorite).

Even though I didn’t have an ounce of wrestling experience, I decided to give the wrestling profession a stab. I called Jim Crockett, who headed the National Wrestling Alliance (NWA) and told him I was interested in slamming bodies as a wrestler. He saw that each muscle was ripped to near perfection. Crockett immediately fetched Ivan Koloff,

and Don Kernodle. Both men were among Crockett’s top-of-the-line wrestlers. Ivan played the role of a mean wrestler from the Soviet Union while Kernodle’s character was that of an American defector who sided with the Russians. The two men formed the championship team in the wrestling enterprise. As soon as Ivan and Kernodle saw me they knew they found the “nephew”. I immediately signed with the NWA.

I was told that I would play the character of a Soviet wrestler, looking mean and wearing a chain. I was immediately put on the set for interviews, instructed to stand silent with folded arms and a scowling face, behind Kernodle and Ivan. I played my part well. Because of my association with Ivan and Don, I gained an immediate disliking from the fans.

My rise to stardom came quickly. Playing the part of a Russian during the Cold War was about as evil as it got. It was a role that I took serious, extremely

serious. Fans booed me like no other wrestler and death threats against me were common because fans believed I was a threat to America.

I developed the character as a Soviet wrestler who was suppose to compete in the 1984 summer Olympics Games in Los Angeles which was boycotted by the Soviets. The character was supposed to be a superstar athlete who was gunning to win medals in track, field and wrestling.

During 1986 I reached the top for those playing the bad guy. I was voted by fans as the No.1 most-hated wrestler.

Eventually, I changed from the ugly Russian who hated Americans to one who fell in love with the country and became as loveable as hot dogs and apple pie. A top wrestling magazine ran a cover photo of my face with a tear trailing down my cheeks. The caption said I was crying for my friend Magnum TA. That sealed

my new image.

I played my new part to the hilt. My switch to the gentle Russian was complete. Dusty Rhodes and I formed an alliance nicknamed "The Superpowers". For the next 18 months, everywhere we wrestled the house sold out. Our accomplishments included many victories over the "Four Horsemen". In 1987, I was voted "Most Inspirational Wrestler" of the year.

I left the ring in 1988 to tend to my critically ill 25-year-old, soon-to-be wife. It was during this time that we wed. Mandy's condition steadily worsened and by early 1989 her fight was over.

Over the next couple years, I became close with Mandy's best friend - whom I never really knew until after Mandy's death. As our fondness for each other grew, I proposed and Victoria accepted. We married on August 17, 1990. Victoria, Nikita, Teryn and Tawni (Victoria's daughters) became an instant family. Our marriage was

further blessed with our daughters Kendra, who was born in June 1992, and Kolby, who was born in May of 1996.

After taking three months to recover from hernia surgery, and rehabilitating my neck from an injury I received during a match, I decided it was time to retire on top of the wrestling profession.

Upon my retirement in 1993, I found myself reflecting back on my life and career. Evaluating all that I had accomplished, the accolades, the fame and the fortune, I was confused as to why I still felt empty inside. The world told me that fame and fortune would make me happy, but I had all of these things and was still unfulfilled.

In October of 1993, I stepped into a church service and when an altar call was given, in an instant, I immediately knew what was missing in my life: A relationship with Jesus Christ. As much as the rejoicing of fans raised the roof the night that I



came to wrestling superstar Dusty Rhode's aid against the Horsemen, the response pales in comparison to the rejoicing of the angels in heaven the day that I bowed a knee at the altar of salvation.

My life has never been the same.

The last decade of my journey has far exceeded the first 34 years of my life. The Holy Spirit has been with me every step of the way. I have been privileged and honored that the Lord has opened doors all over the world for me to minister. I have spoken in churches, schools, prisons and the streets of the U.S. and the world. As I have shared my story of how God performed "heart surgery" on me, I have witnessed thousands come to Jesus and experience God's awesome power of changing their hearts and lives forever.

My zeal for Jesus continues to grow day by day. ♦

IN MY LIFE

No matter how wealthy I became, I was always seeking for happiness and fulfillment. I grew up as an American Armenian and was very proud to attend the Armenian church. I also attended St. John's, an all-boy Catholic high school and graduated from Bentley College with Honors. After college, I moved to New York City and worked off Wall Street for an international public accounting firm.

A family friend suggested that I could maximize my abilities and talents and make much more money in sales. He said, "You

have a great personality and communicate well with people." Having aspirations to become wealthy, I started my first sales position with Moore Business Forms in Rhode Island. I achieved "Rookie of the Year" and had finally found my niche.

I had a job offer in Houston, Texas working for Uarco Business Forms. They gave me the opportunity to handle the world's largest corporation, Exxon. Much to my surprise, Uarco had not done business with Exxon, but within six months of my arrival, I put together a million dollar

contract with Exxon. I was excited because I was making more money than ever before!

I felt an overwhelming desire to get into my own business, so I purchased a service company in the restaurant industry. My business more than doubled the first year. I started to live in the fast lane, enjoying all the privileges of being single and financially successful. I bought a new BMW, but it didn't fill up the void in my life. I had many friends who partied with me and enjoyed the wild lifestyle, but I knew something was missing.

A friend of mine told me that there was a prophet from Arkansas who was going to be teaching at a Bible study. I asked, "What's a prophet?" They responded, "Someone who hears from God." I said, "Oh yeah, if they hear from God, then my name is John Wayne!" I thought that all of the prophets died in the Old Testament. I believed in God and prayed to God, especially when I had a need, but I never heard from God. I did not believe that God spoke to or through people, but I did believe

in the psychics and tarot card readers and enjoyed what they told me. I always wanted to find out what was going to happen tomorrow, today, so that I could be one step ahead of the game. My friend said, "Gil, this Bible study will change your life!" Something touched me inside my heart, so I said that I would go.

My life-changing experience happened the night I attended the Bible study. The night started out with praise and worship music, and the people raised their hands as they sang. I was very uncomfortable in this atmosphere and wanted to leave, but I couldn't because I had come with my friends. I started to pray, "Oh Lord, don't let this be a cult!" They finally stopped singing and we all sat down. The prophet had a word from God and prayed for everyone present. When he got to me, he said, "Okay young man, it's your turn." I looked at him, thinking to myself, let's see what you've got big guy!

I knew something special was happening in that room when the prophet prayed for people, but I did not understand it. He started

to “read my mail” and talk about my family, background, past relationships, work and many other personal situations. I was totally overwhelmed. Sometimes, there are things that are only known between you and God. The prophet talked specifically about my personal and confidential subjects, so I knew that he was hearing from God.

When he began sharing things that the Lord had for me in my future, it really captured my attention and I was very excited!

That night when I went home, I was not sure how to process everything that had happened. My friends told me that Jesus Christ was the son of God and that He died for my sins, so that I

could live eternally with Him in heaven. I had attended church and believed in God, but never had a personal relationship with Jesus Christ.

Jesus was a historical, traditional person who died 2000 years ago. I had no understanding how He could help me today. As I got on my knees, I said, "Jesus, if you are real and the Son of God, and can forgive me for my sins, and if you are alive, then come into my heart and be my Lord and Savior." That's the moment that my life changed! When I woke up the next morning I felt like all of the weight of the world was off my shoulders. I was very excited about the prophetic words that God has spoken to me, so I called my friends and told them that I wanted to attend another Bible study. The next night I received the baptism of the Holy Spirit.

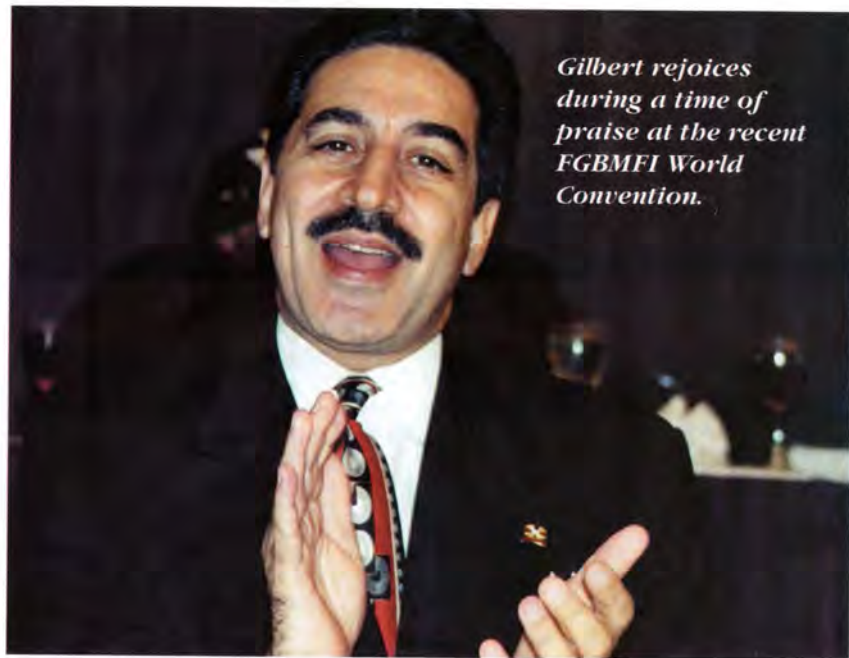
When I accepted Jesus Christ into my life as my Lord and Savior, it completely changed my life. He took out the desire to do things I thought were making me happy. I stopped partying and going to places that were ungodly. God changed me for the better. I

dedicated my business to the Lord when I became born again and now I have peace in all areas of my life. It's reassuring to know that when I die, I will spend eternity in heaven with Christ.

I started experiencing the power of God at Benny Hinn crusades, Tim Storey meetings and a Spirit-filled, born again, Bible believing church. I had finally found spiritual nourishment and true fulfillment. I realized that God still speaks to people, heals bodies, and mends broken hearts.

Right after I got saved, I learned that a man named Demos Shakarian had founded Full Gospel Business Mens Fellowship International. This caught my attention because he was Armenian. I got involved and became a lifetime member. I remember the first time I shared my personal testimony at the Houston Northwest FGBMFI meeting, my father got saved! Later, I had the honor of becoming a National Director of FGBMFI.

I had been single for 43 years, yet I had an intense desire to be married and have children. God

used Tim Storey to introduce me to my wife, Mary Ann. She is a professional singer who had ministered with the two men of God who had greatly impacted my life, Benny Hinn and Tim Storey. We are now married and have two children, Matthew and Elizabeth. We reside in Houston, Texas. I have my own successful business consulting firm helping business owners develop strategic alliances with other companies.

Mary Ann and I host the Trinity Broadcasting and Daystar

Television Networks in Houston, Texas. We have hosted such greats as T.D. Jakes, Marilyn Hickey, Rod Parsley, Tim Storey, Evander Holyfield, Hilton Sutton, Charles and Frances Hunter, etc., dealing with important issues that effect everyone's lives.

The message we share is that true peace and fulfillment cannot be found in money, recognition, or "religion", but only in a personal relationship with Jesus Christ! ♦

Racing With The Wind

A high-speed police chase disrupted the peace on a hot August night in Clearwater, Florida. The car being pursued came to a screeching halt and the young suspect jumped out blasting the police cruiser with buckshot.

After blasting the passenger side of the car, the suspect turned to flee. The next bullets fired were by the police officer hitting the young man square in the back of the head!

That young man was me, Ricky Leonard. The officer was using a .38 caliber, "police special," with hollow-tip bullets. In his report, the officer stated his 4th or 5th shot struck me in the back of the head from about 30 feet away. Transported to Morton F. Plant Hospital in Clearwater. Dr. Pittman was the neurosurgeon on duty that evening, where I underwent surgery for nearly 7 hours. The doctor removed lead and bone fragments imbedded in my brain up to 3 inches deep!

Later, the doctor told my mother, that "if" I recovered I would be paralyzed, have severe brain damage, grand mal epilepsy (characterized by violent seizures) loss of motor skills, balance and coordination.

After I awoke from a coma, all of these afflictions did exist, and much more. Though I could not move or walk, the police had me under a 24-hour guard in the hospital. Twenty days later I was placed in a wheelchair and taken to the county jail. In January of 1975 I was sentenced to spend 30 years in prison; my release date was 2004!

While in the county jail I learned how to pull myself up and shuffle

back and forth along the bars of my cell. They shipped me off to the state prison. Medication was given to me for severe headaches. synthetic cocaine, synthetic morphine, plus 300 mg. of Dilantin with Phenobarbital, anti-blood clotting agent, medication for asthma and more...(I was given that same medication for 4 and 1/2 years).

About six months later, at a prison in Arcadia, Florida, a man came up to me who had become a Christian just a week before. He was overcome with his new found joy and greatly excited about how God had transformed his life. As I was trying to open my wall locker he grabbed me by the front of my shirt. He said that I needed to know the Lord as he did, and he wanted to take me to chapel on Sunday! I said, "Sure, lets go right now!" The way this guy came on so bold, I thought I was dead meat! What kind of crazy guy is this?

On Sunday he came and took me to the prison chapel. Then, every time the doors of the church were opened he brought me to church! He did not give up. About 3 weeks later I had gone to a

special Bible study meeting, but only to get the homemade cookies. As we drooled over all those goodies, the chaplain said they would have a testimony time first.

These men who lived their life for God, began to tell how they had been changed by the power of God. Their hatred, bitterness, hopelessness and fears all removed by the transforming power of God as they invited Jesus into their heart. The Bible says, "The Word of God is quick and powerful...". After several men told of their conversion a strange thing happened. Before I realized what was going on, I was on my feet with tears in my eyes. I said, "Men, I don't know what this Jesus stuff is all about, but if He can change your life...I need Jesus!" That night things began to turn around; change began to take place on the inside of me.

There was such a hunger for God in me and a desire to know Him. As we prayed and talked with God

everyday, the change became evident. Even with 30 years hanging over my head, and being without hope physically, I too had peace and joy. All my hatred and bitterness were gone!

Four and 1/2 years later, while working as a Chaplains' assistant in Zephyrhills prison, God moved

in my life in a phenomenal way. One evening 2 men met me as I was leaving the chapel. One said he had a vision of a crippled man being healed, the other had told him of me. That day during lunch the man fasted and prayed, "Lord, is this the man you showed me in that vision?" The Lord said to him, "Yes, go and tell him I am going to heal him and that revival will break out here because of it."

At 4:50 p.m. on March 10, 1979 Lou and Tim told me what the Lord had spoken to Lou that day. They asked if I knew any Bible verses that promised healing. According to Matthew 18:19, we agreed together in prayer, "Lord I am sick of being sick, I am sick of taking pills, you foul spirit of epilepsy I bind you in Jesus' name, get out! Father, I believe that I am healed from the top of my head to the soles of my feet. In Jesus' name, Amen."

At 5:00 p.m. as I said "Amen", the whistle sounded which is a call to return to our dorms. Each day I was the last one in the dorm due to my being crippled and physically wracked. But that day, I ran! I ran from the front of that prison to the rear, up the stairs of

the dormitory and down the hall to my room. Healed! No more paralysis, brain damage, epilepsy, loss of equilibrium or asthma!

Not long after, I realized that a girl I had been writing to in Riverside, California, had fallen in love with me and I with her through the mail! In October of that year she came to Florida to visit me in prison. God confirmed that love to us on her first visit.

A few months later Mary O'Brien moved to Florida to be near the prison to visit me and pray me out of that place. The Lord intervened on my behalf; my sentence was changed from 30 years to 15 years; then reduced further! Then reduced again as I was on work release in Tampa, Florida to two weeks!

One week before being released, as I spoke to the Lord, he said, "I want you to preach the gospel and give your testimony around the world". I was released in March of 1981. Mary and I were married in May of the same year. Today we have three great children serving the Lord and are still very happily married.

Since 1981 I have been an evangelist, traveling to many countries with the good news of Jesus Christ. Our ministry is based in Wilmington, N.C. I am totally sold out to Jesus Christ, a fanatic for the Lord! My desire is for the Lord; to never stop praising Him and serving Him. I have never had so much fun in my life! Every day is a new adventure. It is so great serving Jesus!

There is a God-designed purpose for your life. He does

not play favorites. What He has done for me, He will do for you...and, even greater things, if you will only believe and place your trust in Him. ◆

Managing my accounting office, running a vocational-technical school and being actively involved in volunteer organizations gave me little time to serve my church and my city government. But God had other plans.

When the national election came for the national and local officials in 1992, I wanted to run for City Councilor. But before filing my candidacy, I first went to consult the Lord if He will allow me. He said, "Yes, I will allow

you but you have to be prepared for any kind of trial. I will make you a Councilor, as long as you follow my instructions." I filed my Certificate of Candidacy and then campaigned accordingly. On the night of the counting of votes, I went to sleep trusting in my heart that tomorrow I will already be a councilor.

During the campaign time, I made it a condition with my party that I will be their chaplain and that in every campaign meeting, there must always be an opening

prayer. In the City Council is an opening and closing prayer. Humbly, our presence in the group made them aware that there is a man of God in the crowd. One of the conditions of the Lord when I entered politics was, that I would put Him first before my job in the Council. Three years after my first term as Councilor, I ran again with the permission of the Lord; and I won again.

When the election of 2001 came, I again asked the Lord if He will allow me again to go back to the City Council, and again He said yes. This time I became more aggressive in my ministry in the city. I called for all of God's ministers to support a campaign for winning the city of Baguio for Jesus Christ. I won again for the seat of City Councilor.

We now have a regular breakfast meeting of ministers to pray, monitor and initiate activities on the vision of winning Baguio for Christ.

When I started praying the prayer of Jabez on extending my territory, the Lord opened more

ministry area within the city government. We are now conducting two hours of a Spiritual Transformation program for all officials and employees, numbering 1,200, grouping them in 50's or less.
